RELATIONSHIP BETWEEN QUALITY OF AUDIT AND PERFORMANCE OF COOPERATIVE SOCIETIES IN ODO OTIN LOCAL GOVERNMENT AREA OF OSUN STATE, NIGERIA

ABSTRACT

The research investigates the impact of audit quality on the performance and accountability of Odo-Odin Local Government area cooperative society. The study is aiming at examining the effects of quality audit on Odo-Odin Local Government cooperative performance, the study intends to determine the extent at which internal audit affect Odo-Odin Local Government cooperative performance, the study also investigates how the quality of audit impacted on Odo-Odin Local Government area cooperative society. Descriptive survey research design was employed to achieve the objectives of the study. The research used one hundred and thirty (150) copies of questionnaire for the analysis of data collection. The correlation result indicated a substantial and strong association between Odo-Odin Local Government cooperative society performance and audit quality [r (150) = 0.674, p0.01] 67.4 (67.4%). The performance of the Odo-Odin Local Government cooperative society and audit quality are positively and significantly correlated. According to the correlation analysis, [r (150) = 0.341, p0.01]There is a considerable correlation between the conduct of the audit and the cooperative society for Odo-Odin Local Government (34.1, or 34.1%). Statistics were obtained from the Okuku Odo-Odin Local Government Area. The research's findings were presented using regression analysis. The report suggests that Nigerian corporate auditors work as expected and that professional bodies always keep an eye on governmental acts and raise awareness of practices that can make it difficult for auditors to carry out their duties effectively, particularly when auditing cooperative societies in Nigeria. It was also suggested that corporations increase the frequency of their audit committee meetings.

INTRODUCTION

Cooperatives have advanced in many areas of the Nigerian society and economy where, primarily, agricultural cooperatives have seen significant progress and prosperity due to the agrarian nature of the economy. The significance of cooperatives in financial strengthening and destitution decrease cannot be overemphasized. Businesses have to be purposely founded inside control methods pointed at accomplishing objective stand the hazard of wasteful and can indeed fall out of the scope of commerce. Firm disappointments, particularly within created world have sensitized firms to be proactive.

Implementation of a utilitarian system of inner control would regularly improve dependable money related announcing, operational effectiveness and compliance with directions and laws (Nyakandi 2021). Execution is seen as advantage era, survival, viable and effective operation and capacity to successfully respond to both inner and outside environment (Podhana R.A 2013). Cooperative will as a rule not use assets in setting up a great inside control framework due to measure, need of stores and information. The nonappearance of proficient and compelling inside control framework, among numerous other reasons, might influence the execution of businesses.

Gatawa and Aliero, (2015) concluded that from 1936-1956, formal cooperatives have spread from the western to the eastern and northern parts of Nigeria, although it was not yet popularly recognized in the Northern part of the country. Marx and Seibel, (2012) revealed that cooperative societies based on indigenous savings and credit associations were more effective in mobilizing personal savings and in terms of all other economic indicators than cooperatives without such basis. These cooperatives are interest based cooperative societies which are not in conformity with the Islamic law. Ajani & Adebayo (2018) concluded that the un-Islamic nature of the conventional cooperatives and the need to improve economic activities in accordance with the Shari'ah law brought about the formation of Islamic cooperative societies (ICS).

Cooperatives can either be operated on conventional basis or on non-interest basis. Rasaki, Kamilu, Rukayat & Balkis (2018) concluded that, Conventional cooperative society is based on a pure financial intermediation model, where the society's profits are the margin between the interest earned by members from their savings on one hand and the interest from the funds

Particularly, the study looks at the impact of quality audit on execution of Odo-Odin Local Government are cooperative, evaluate the internal audit level on execution of Odo Otin Nearby Government Cooperative, and to decide review quality on the responsibility of Odo-Odin Local Government cooperative of Odo Otin Local Government. The Research Questions states; what are the effects of quality audit on Odo-Odin Local Government cooperative performance? To what extent has internal audit affect Odo-Odin Local Government cooperative society? This study will be of significant to the public and also different sector in the economic in order to have adequate understanding regarding the concept of Audit Quality and its effect on Society Cooperative. -Members are encouraged to engage in economic production and services that promote gross domestic product and national income by providing ready market for their products.

-Employment opportunities are created either directly by the cooperative or through members of the cooperative.

-Apart from assisting members to participate in international trade, cooperatives make it possible for Nigeria, through members representing the cooperatives at international apex, to sit among the community of nations.

-The cooperative democratic principles and practices trained their leaders as good community leader.

-The members' standard of living has increased and the cost of living as well been reduced.

Theory of Inspired confidence

The capacity of an association to successfully and effectively use assets available to its to accomplish its objectives and targets is alluded to as execution (Azul, S.H, Jeryer M 2013). It is beyond the realm of possibilities for a firm to accomplish its objectives and goals except if it successfully and effectively plays out its tasks (Van Cung, H.Luis 2020). In this review, functional proficiency is utilized as the intermediary for estimating execution. By functional effectiveness, we are alluding to a company's capacity to however much as could be expected, diminish squander in materials, time and exertion regardless convey items or administrations that are of exceptionally top notch.

Circuit Hypothesis

One more hypothesis that relates review quality to corporate execution is the flagging hypothesis which sees review as a component that can moderate data imbalance among related parties. Flagging hypothesis, as indicated by Spence (1973), recommends that organizations with great execution utilize monetary data divulgence to convey positive messages to the market about their true capacities. The positive sign of straightforwardness and believability which high review quality ships off the market, gives confirmation to the partners about the nature of profit revealed in budget summaries and recommends a positive relationship between market-based execution and review quality.

3. METHODS

Descriptive survey research design was employed to achieve the objective of the study. In the quest for information required for this study, the researcher made use of a major source of information that is Primary data from worker of Odo-Odin Local Government Area (Council) cooperative society, Okuku. Primary Data was used and it made use to gather data directly from the research population through the use of questionnaire. The questionnaire is usually typed questions to which respondents will provide written responses.

The research used one hundred and thirty (150) copies of questionnaire for the analysis of data collection. The sample of 242 (obtained through adoption of Yamane, 1967 formula as stated below) was considered appropriate for this research. As it is not unusual, the researcher could not get to the entire population. Therefore, the need for sample size determination arises. Sample was derived mathematically from Taro-Yeme's formula.150 copies of questionnaire were distributed in total.

Data were analyzed, presented using simple frequency tables, charts, figures to explicate socio economic respondents status. The hypothesis will be tested for acceptance or rejection using the correlation analysis.

4. RESULTS

CONCLUSION

The result of study showed that audit quality increases the performance and accountability of the organization, audit quality improves Odo-Odin Local Government cooperative society activities, internal audit improves Odo-Otin Local Government cooperative performance. The likelihood of a good audit assignment would unintentionally rise with knowledge of these aspects that could greatly affect independence of audit and strict respect to the laws regulating cooperative organizations. This will improve the detection and reporting of false presentation financial reports while also increasing the users of the financial statements confidence. As a result, quality of audit improves and potential effect on cooperative societies is increased.

6. RECOMMENDATIONS
